Wellcome Trust Public Engagement Funding

MYRIAD is funded by a Wellcome Trust Strategic Award and the Wellcome Trust has also awarded us some additional for funding to develop and deliver a programme of public engagement activities. We are using this funding to engage young people with the ongoing research, integrate their perspectives into the project, and inspire an interest in psychological science. We have been working with a team of public engagement consultants to develop these activities. We are delighted to offer a range of research-based workshops, details of which can be found in the 'Inspiring an Interest in Research and Science 2018/19' document, which will be sent to your school's Research Lead. We will let vou know about further activities soon.

Oxford University Widening Access and Participation

Oxford University has published its first Annual Admissions Statistical Report showing undergraduate admissions statistics. Recognising that there is more work to be done regarding widening access and participation, the University has announced that it will be making an extra 500 places available on its UNIQ summer school for UK state school students in Year 12. Participants in the UNIQ summer school stay in an Oxford college or annexe for a week, attend lectures and seminars in their subject, and take part in workshops about applying to Oxford.

GDPR Update

The General Data Protection
Regulation (GDPR) came into force
on 25th May. Many GDPR principles
are similar to the old Data Protection
Act (1998) with which the MYRIAD
project already complied. The GDPR
includes new and strengthened
requirements for how we protect
people's data. We have written to all
schools taking part in the project to
provide necessary additional

Q & A with Anam Raja, MYRIAD Research Assistant



How did you come to work on the MYRIAD project?

After getting my MSc in Social Psychology I joined a children's research charity where I worked alongside national charities, government departments, and schools on evaluation and implementation research around the different
